# June 2010 consumer survey

#### **CONSUMER CONFIDENCE PICKS UP AGAIN IN JUNE**

The consumer confidence indicator has recovered in June, after having fallen back sharply last month.

Consumers appeared distinctly more confident about future developments on the labour market. Fears of a resurgence of unemployment have thus faded, as has generally been the case for the last few months. After dropping sharply the previous month, prospects for the general economic situation in Belgium have firmed up as well, albeit to a lesser extent than forecasts solely concerning the labour market.

Besides the more optimistic assessment of the macroeconomic aspects, consumers are also expecting to bolster their financial means and saving capacity over the next twelve months.






# **General economic situation in Belgium**




# Unemployment in Belgium<sup>1</sup>
