INTERNATIONAL COMPARISON

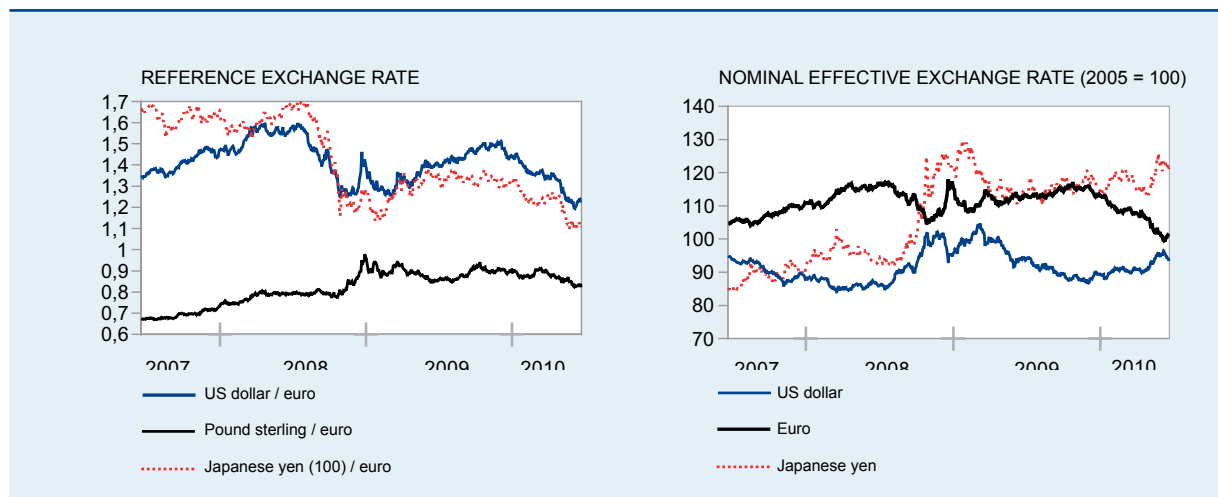

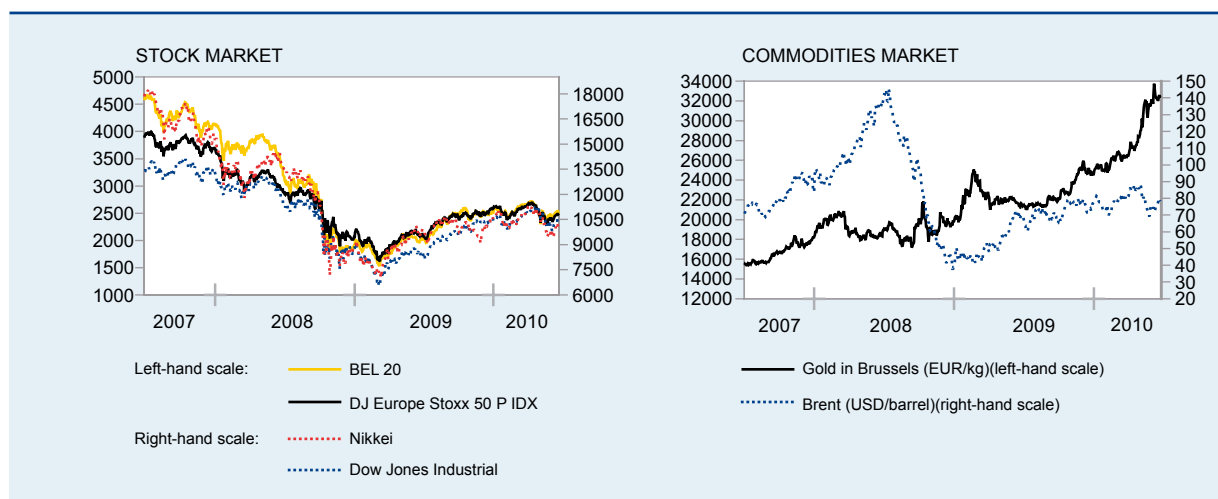
