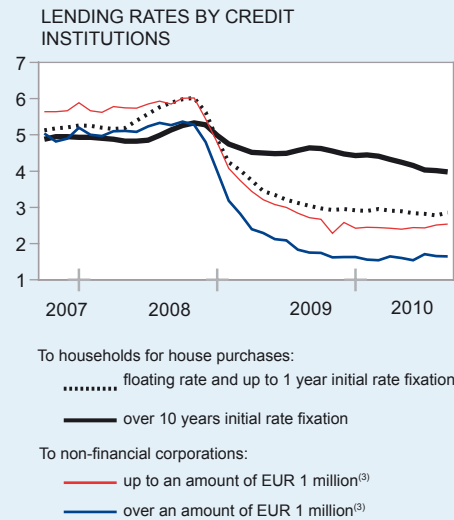

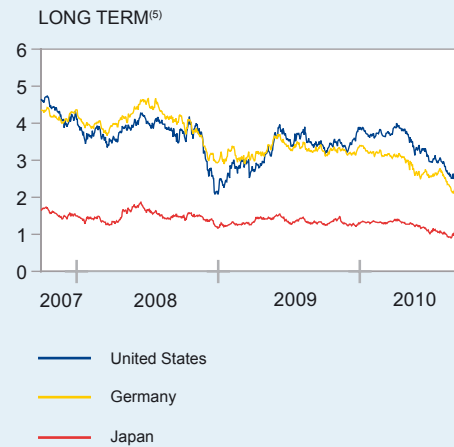

INTERNATIONAL COMPARISON

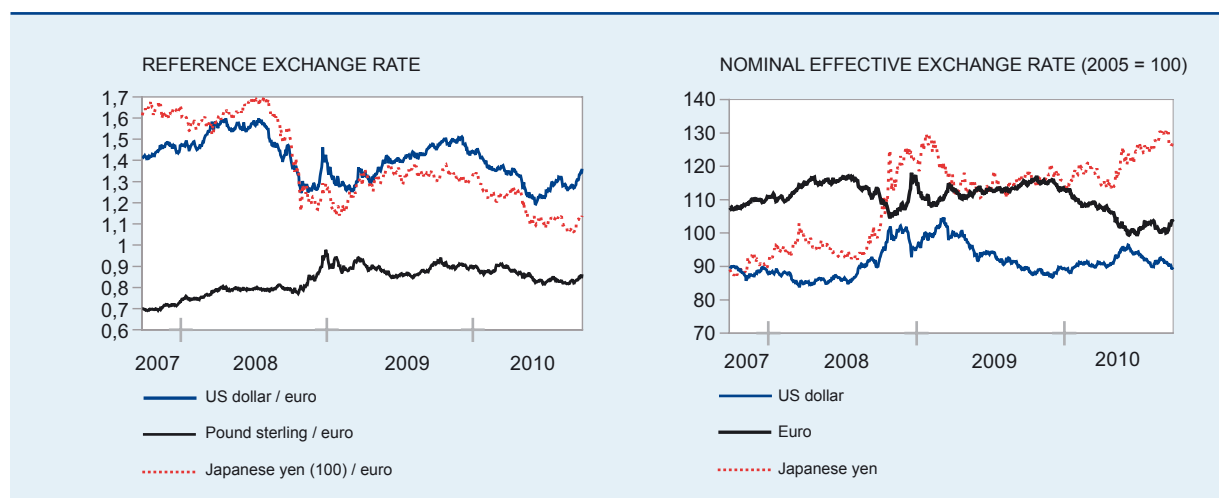

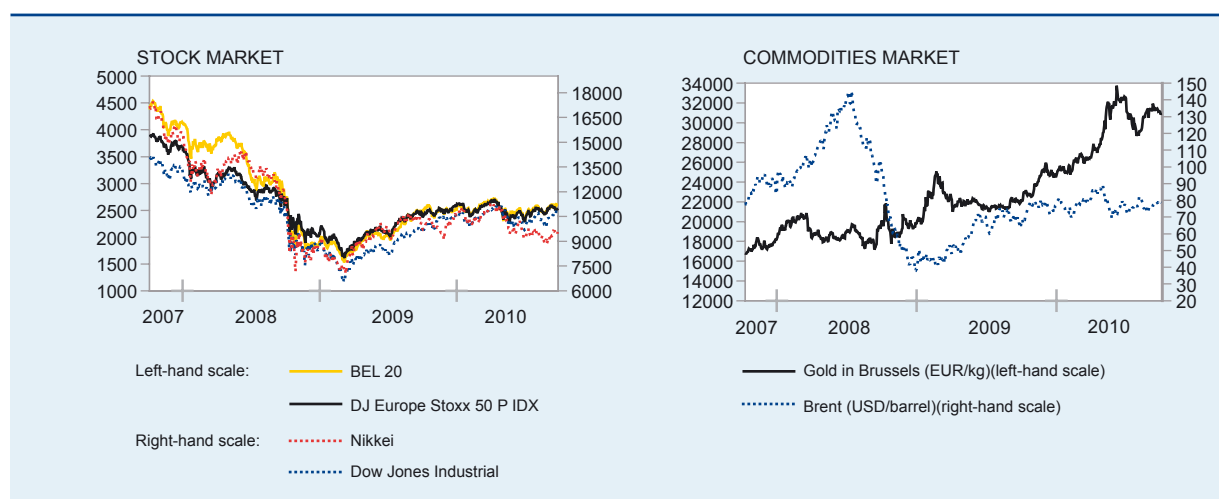
