 ● Seasonally adjusted series



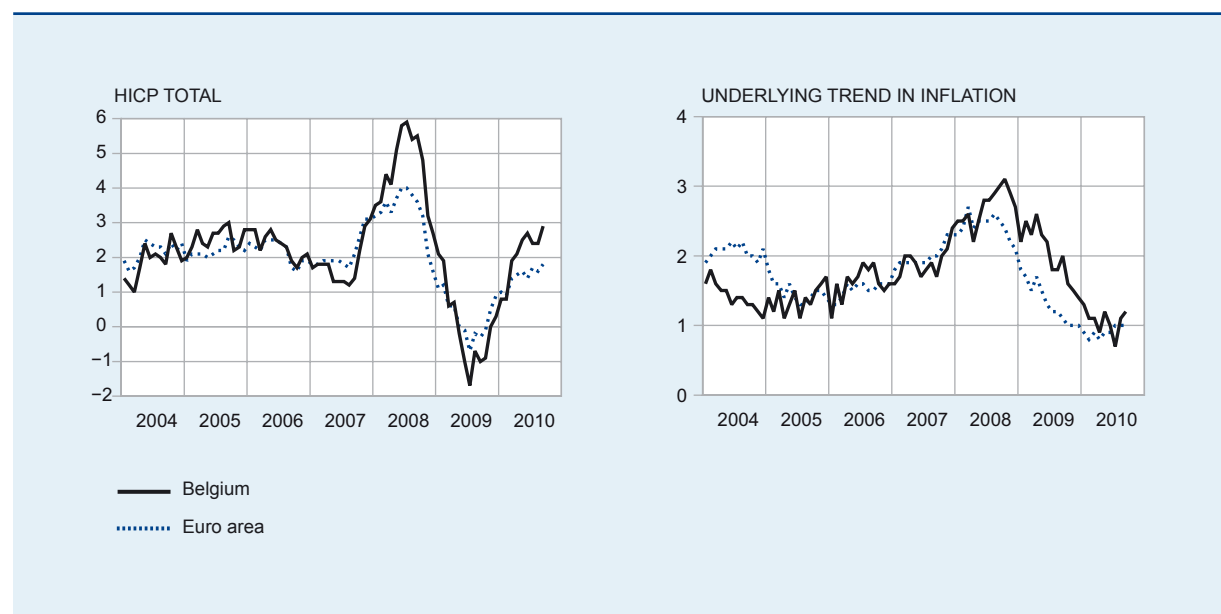

INTERNATIONAL COMPARISON

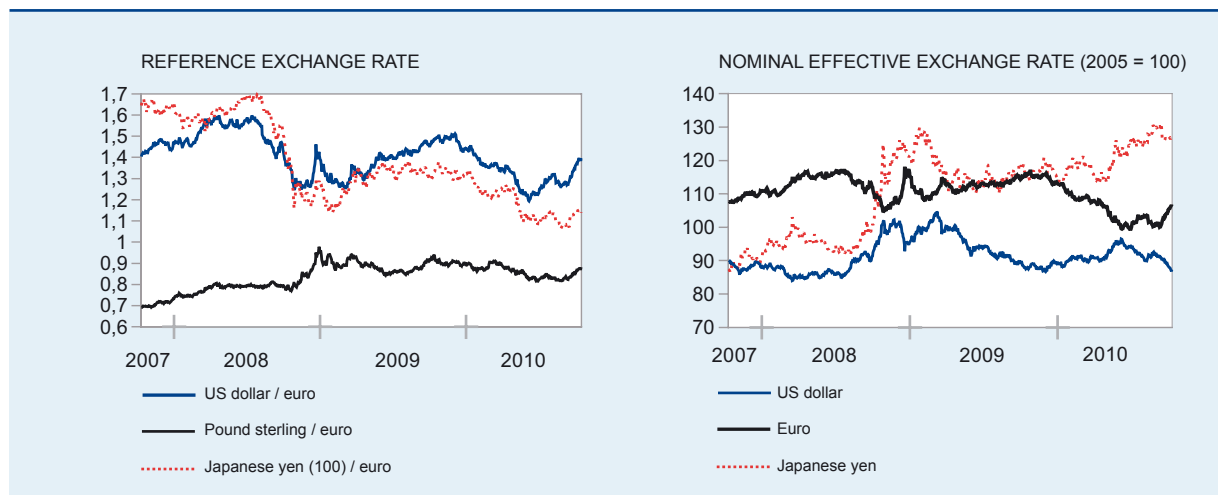

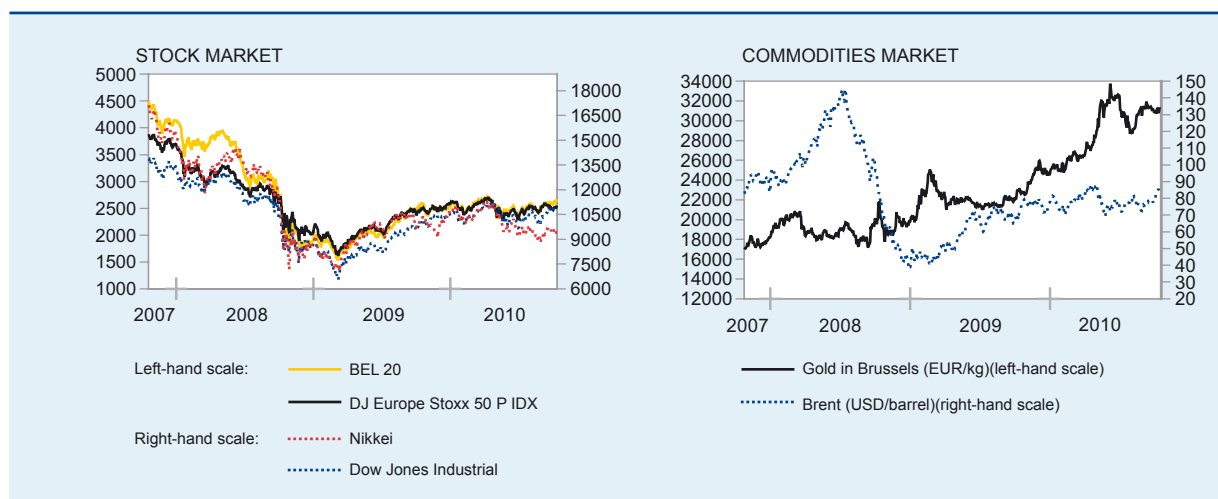
