N.B.: The National Bank of Belgium uses a new method to elaborate the external trade statistics based on the national concept since the publication of the statistics related to November 2009. Presently, this method is only applied on the compilation of the statistics after 10 weeks to assure a certain level of soundness. In order not to disrupt the necessary cohesion between different frequencies of publication of those statistics, the publication of the flash estimation after 6 weeks is temporarily suspended.

INTERNATIONAL COMPARISON

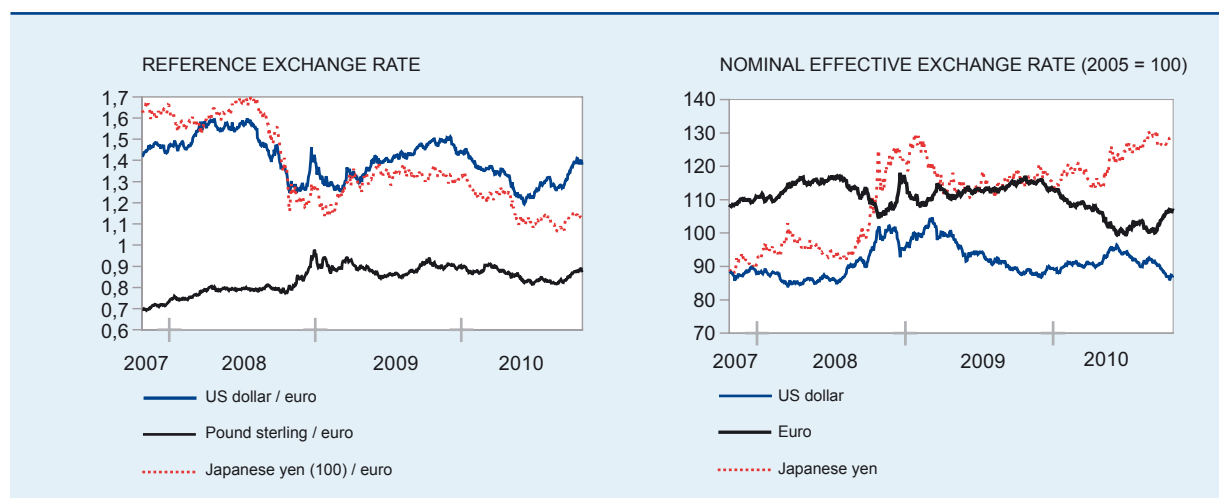

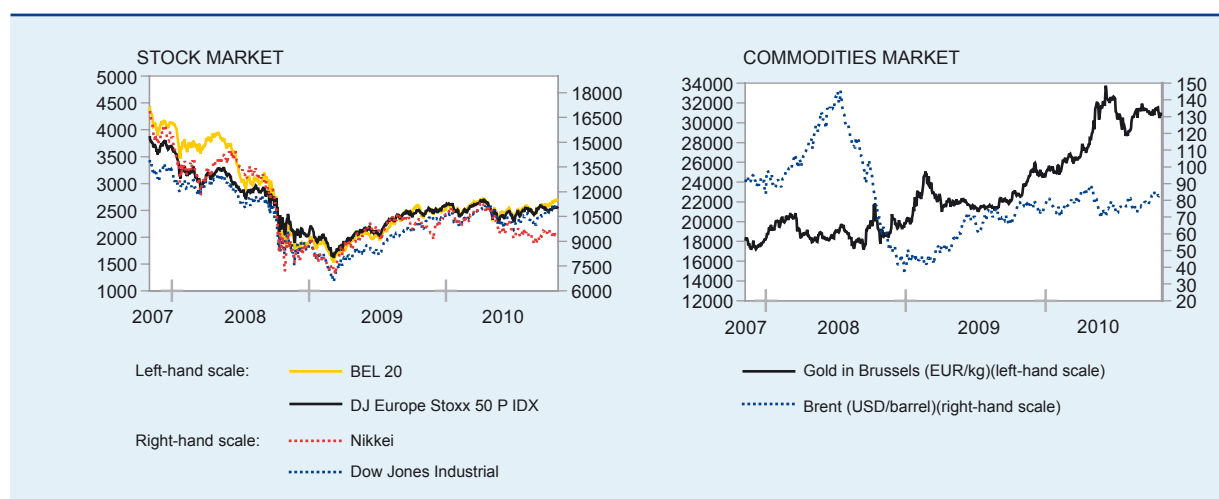
