 — Seasonally adjusted series



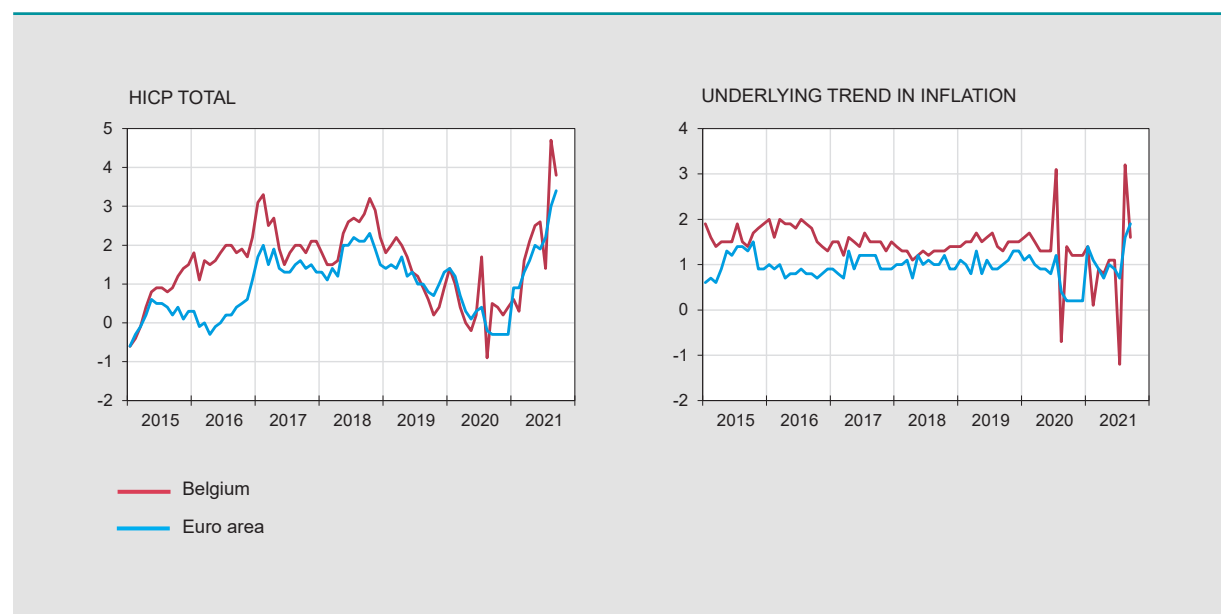

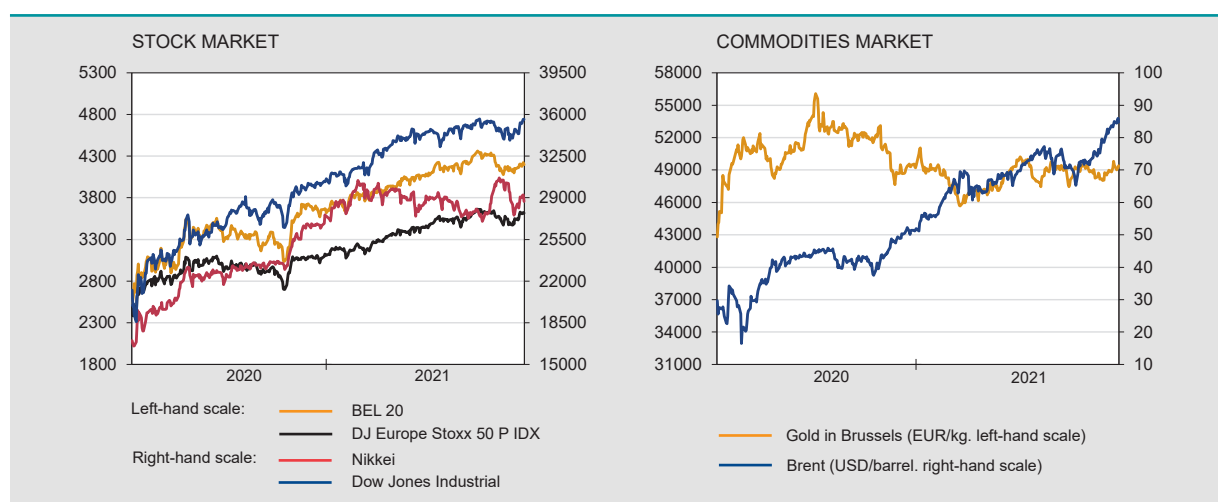
