## Future qualitative documents collections will be performed on OneGate

As from 2022-10-03 in **eCorporate**

- Documents with a **reference date < 2022-09-30**
- All already-existing document collections in eCorporate with a « once » collection occurrence remain in eCorporate
- A few exceptions (rare) of documents with a reference date  $\geq$  2022-09-30
- No more additions on eCorporate from 2022-10-03 on

As from 2022-10-03 in **OneGate**

- Documents with a **reference date  $\geq$  2022-09-30**
- All documents with an “ongoing” or “on demand” (=“occasional” in eCorporate) collection occurrence

**No identical reporting** will be requested **on both applications**



## The actual end date of eCorporate is being determined

- You will be informed as soon as it is determined
- The **history of qualitative documents** reporting in eCorporate will be fully available on the Supervision portal
- Both the NBB and the Portima **electronic certificates** will **not** be accepted anymore to access OneGate and the new Supervision portal
  - ✓ Belgian e-ID cards remain accepted
  - ✓ NBB certificates are being phased out. Soon will not be valid on OneGate anymore either.
  - ✓ The list of accepted certificates will be provided on the NBB's website

## A portal dedicated to supervisory activities

- Main functionalities
  - Overview of your institution's expected (and closed) **OneGate reports** (qualitative & quantitative)
  - Consultation of the reported non-structured **qualitative documents** (incl. eCorporate history)
  - Consultation of NBB-produced documents: **reporting sheet and identification sheet**
  - Management of your institution's "**attributes**" (= descriptive or technical characteristics)
  - Manage your institution's **users** on the portal

Will be enriched with **new functionalities in the future** to make it the main interaction channel between the NBB and the institutions under its supervision

## A new portal dedicated to supervisory activities opens on 2022/10/03

- The NBB's "**Supervision**" portal
  - Not accessible to the public
  - URL: <https://supervision.nbb.be>
- Main functionalities
  - Overview of the supervision activities (qualitative and quantitative)
  - Consultation of the supervision history
  - Consultation of the supervision sheet
  - Management of your institution's characteristics
  - Manage your institution's **users** on the portal
- Will be enriched with new functionalities in the future to make it the main interaction channel between the NBB and the institutions under its supervision

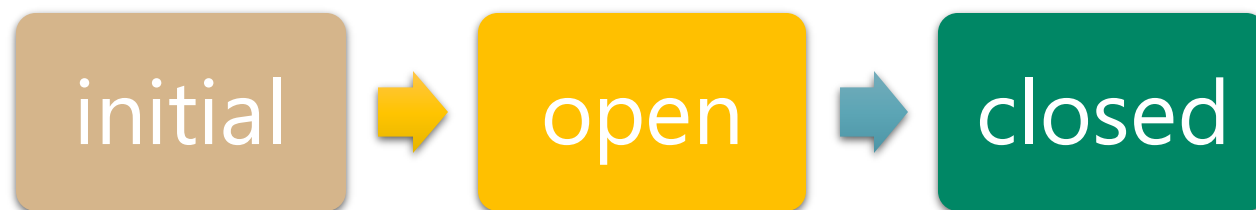

## Be aware of the declaration process on OneGate



- = « to do » > « draft » > « submitted »
- Once closed, reports/forms cannot be modified anymore
- For almost every reports, once they are closed, you **cannot reopen** them (you have to ask the NBB to do it)
- Notable exception: “**ongoing**” collection occurrence





## Users' rights to access each report are all defined in OneGate

### On **Supervision**

- Manage users' rights to use the **portal's functionalities**

### On **OneGate**

- Manage users's rights to access **reports** (and OneGate itself)

**Supervision uses the report access rights defined in OneGate**



## Who manages the users in each app?

### On **Supervision**

- Users managed by any user with "**edit internal users**" right
- A **Supervision "admin"** has all rights by default, including managing users
- Must have at least one admin at all times
- **A first admin is invited by the NBB for each institution on 2022-10-03**

### On **OneGate**

- If certificate:
  - Users managed by the NBB
- If CSAM (**new**)
  - Users managed by your establishment's **OG admin**
  - Need to register an admin with specific procedure





## Use the same mean of connection on Supervision and OneGate

### CSAM or certificates

- CSAM = belgian e-ID card
- Certificates = list provided on the NBB's website (coming very soon)
  - ✓ ISABEL
  - ✓ QuoVadis
  - ✓ GlobalSign
  - ⊖ ~~NBB certificates~~  
(not accepted on Supervision, being phased out on OneGate)
  - ⊖ ~~Portima certificates~~





## OneGate currently has two distinct connection URLs

If you want to connect to OneGate with a **certificate**

- <https://onagate-certificate.nbb.be>
- Users managed by the **NBB** (OneGate Access team)

If you want to connect to OneGate with a belgian **e-ID** (CSAM)

- <https://onagate.nbb.be>
- Users managed by your company's **OneGate admin(s)**



Supervision currently redirects  
you to OneGate's certificate URL





## We will align OneGate with Supervision in the coming months

There will **eventually** be a **single URL** for OneGate...  
...to connect with both CSAM and certificates

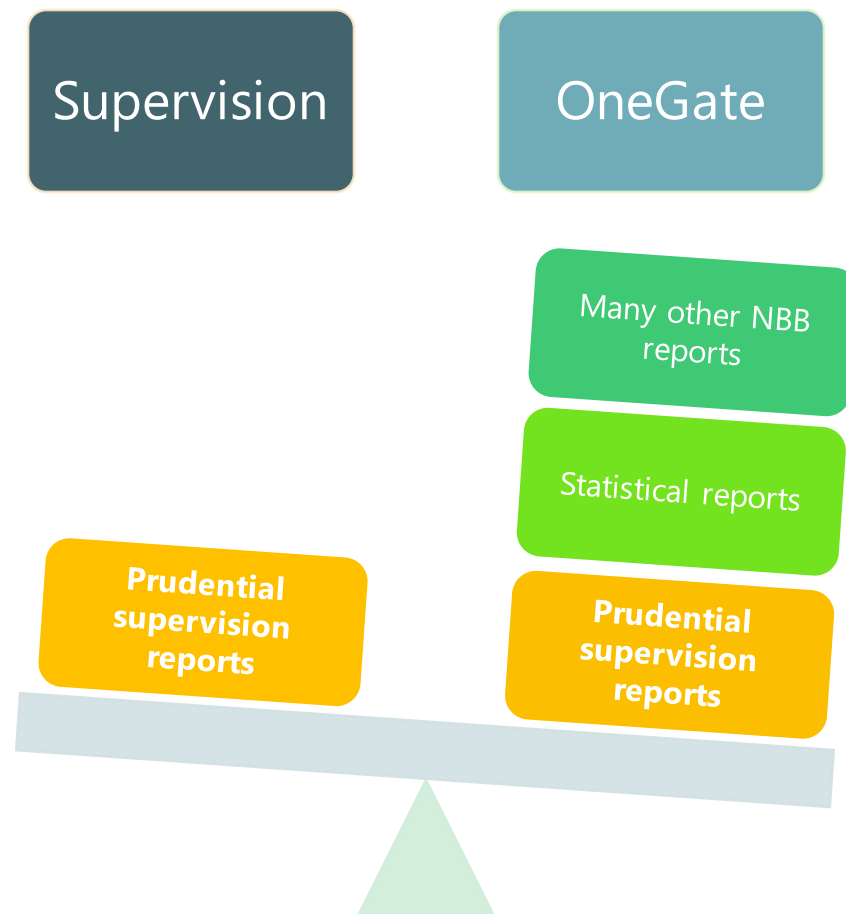
