to the

Framework Protocol on the procedures for the communication of personal data by Statbel to the National Bank of Belgium (NBB) in the context of the National Accounts Institute (NAI)

BETWEEN

ON THE ONE HAND

The General Directorate of Statistics – Statistics Belgium of the FPS Economy, SMEs, Self-employed and Energy, registered in the Crossroads Bank for Enterprises under number 0314.595.348, boulevard du Roi Albert II 16, 1000 Brussels, represented by Mr N. WAEYAERT, Director-General, hereinafter “**Statbel**”,

AND ON THE OTHER HAND

The National Bank of Belgium, registered in the Crossroads Bank for Enterprises under number 0203.201.340, Boulevard de Berlaimont 14, 1000 Brussels, represented by Mr Pierre WUNSCH, Governor, hereinafter “**NBB**”;

Hereinafter “the parties”

IT IS FIRST SPECIFIED AS FOLLOWS

In accordance with Article 20 of the Law of 30 July 2018 on the protection of natural persons with regard to the processing of personal data, before any personal data are transferred to any government agency or private organisation, a federal government agency must formalise that transmission on the basis of a protocol concluded with the recipient organisation.

In line with this obligation, the parties concluded on 9 July 2020 a Framework Protocol on the procedures for the communication of personal data by Statbel to the NBB in the context of the National Accounts Institute (hereinafter “**Framework Protocol**”).

Since the Framework Protocol only applies to situations where Statbel passes on personal data to the NBB and the parties now establish that any communication of personal data by the NBB to Statbel is also necessary so that Statbel can carry out its legal assignments, the parties wish to extend the scope of application of the Framework Protocol to situations where the NBB

communicates personal data to Statbel to likewise make it fall under the Framework Protocol's scope of application. The above-mentioned transfers of personal data shall always take place in the context of the National Accounts Institute.

IT IS AGREED AS FOLLOWS

Article 1 – Amendments to the Framework Protocol

In addition to the procedures for the communication of personal data by Statbel to the NBB in the context of the National Accounts Institute (NAI), the Framework Protocol also governs the procedures for the communication of personal data by the NBB to Statbel in the context of the NAI.

Whenever the NBB communicates any personal data to Statbel, all provisions set out in the Framework Protocol in which the NBB is mentioned in its capacity as the authority that is receiving the personal data and in which Statbel is mentioned in its capacity as the authority that is communicating the personal data should be interpreted in the sense that the authority which is receiving the personal data is Statbel and the authority which is communicating the personal data is the NBB. All provisions set out in the Framework Protocol shall consequently apply depending on the authority which is communicating or receiving the personal data and not according to the name of the parties.

Article 2 – Entry into force

The amendments to the Framework Protocol, as specified in Article 1, shall enter into force on the date on which this Amendment is signed.
