— Seasonally adjusted series



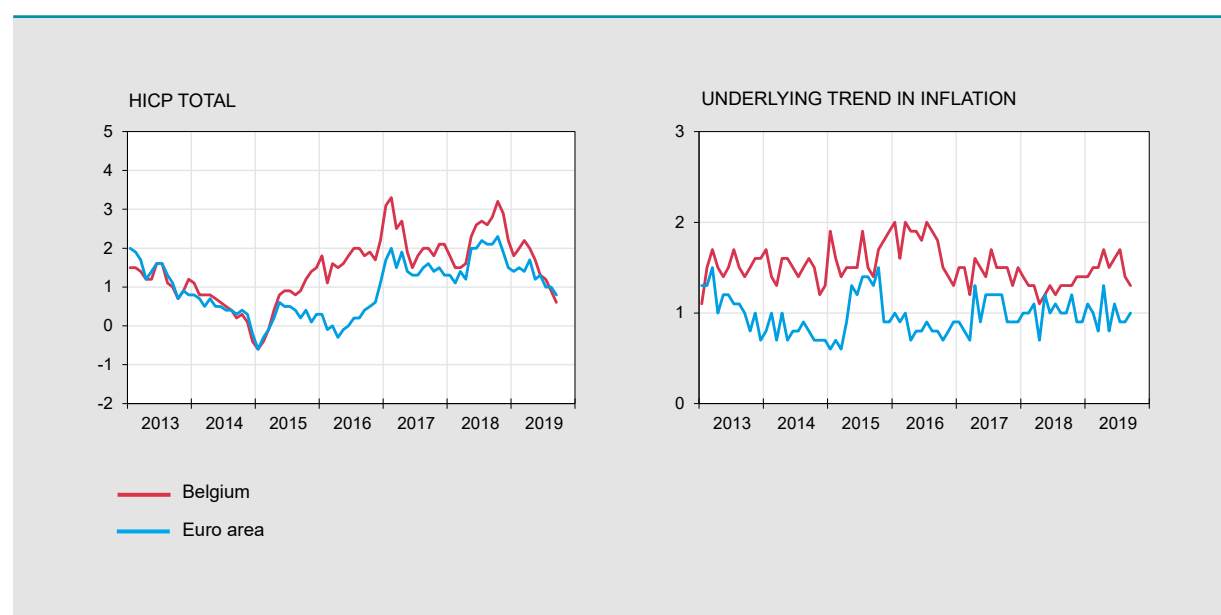

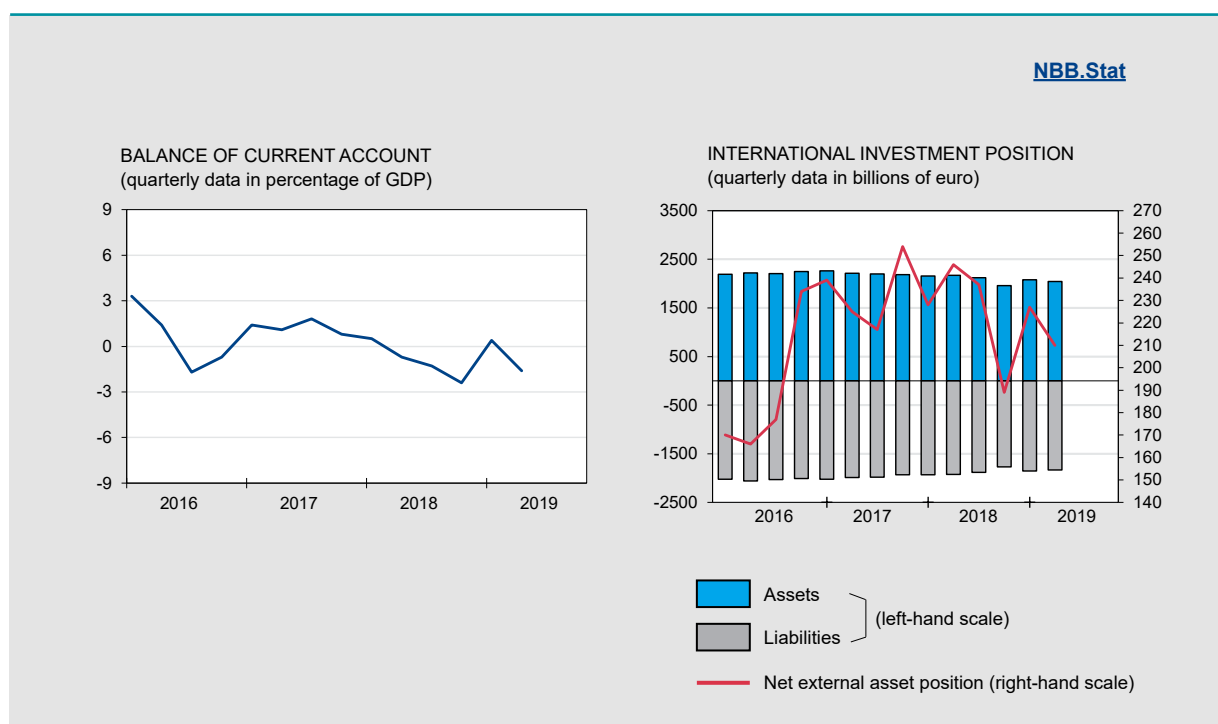

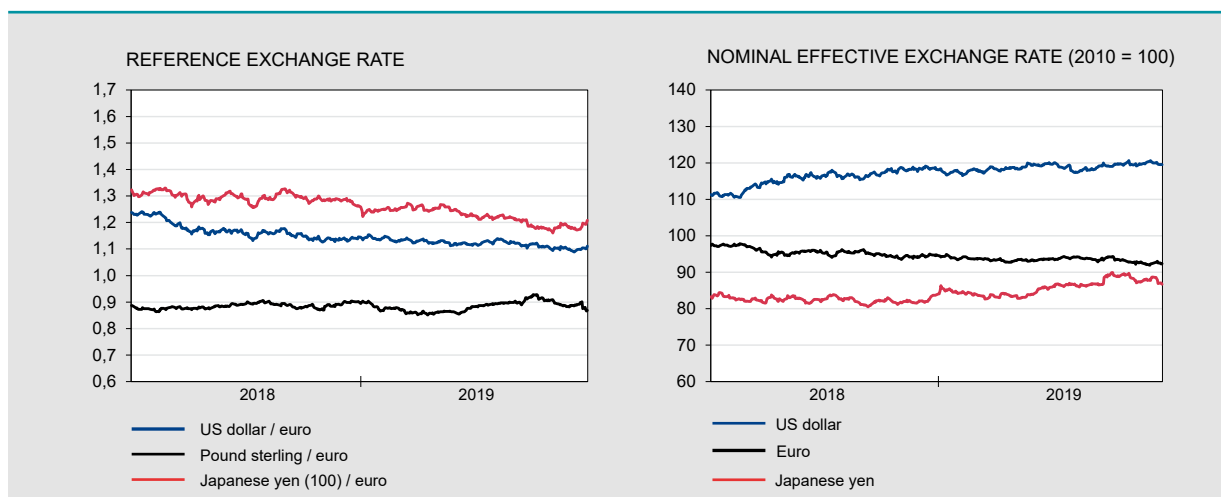

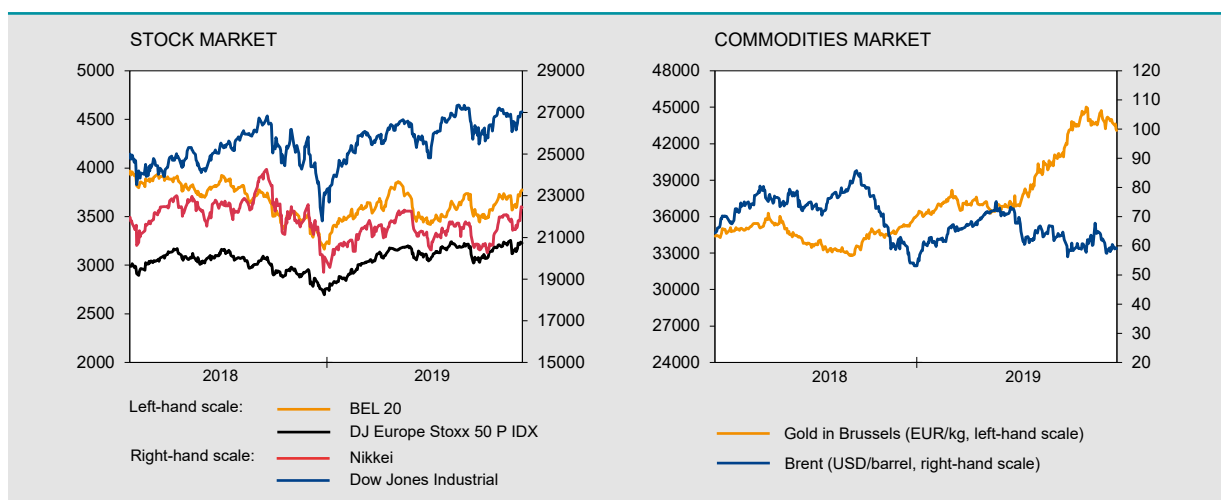
