 ● Seasonally adjusted series



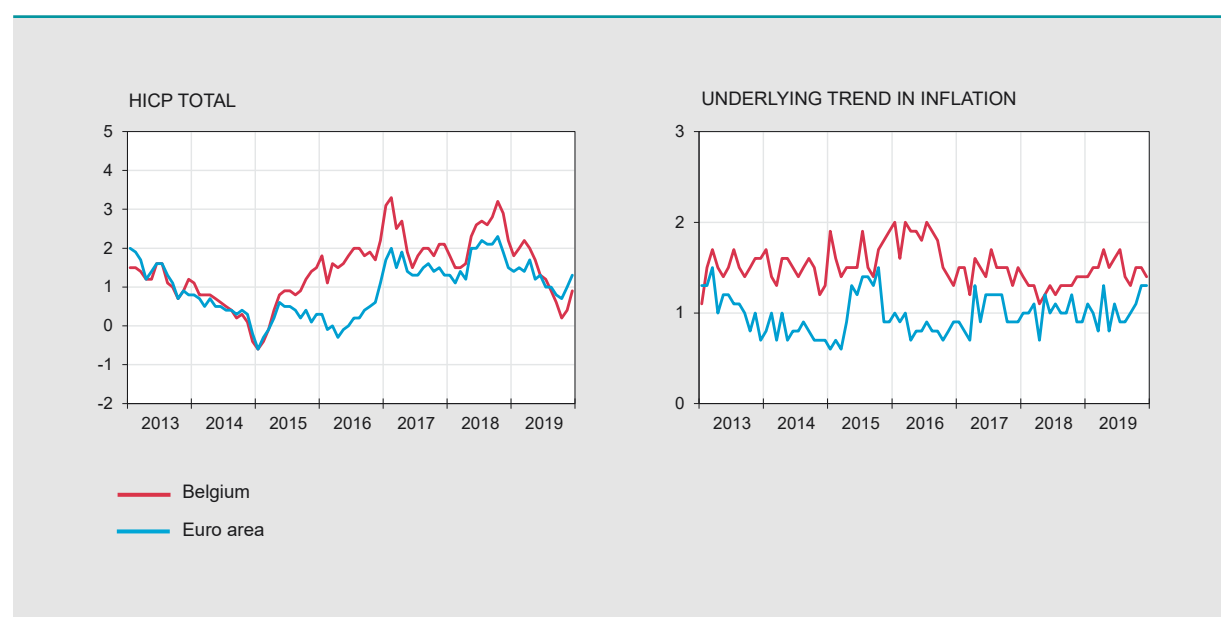

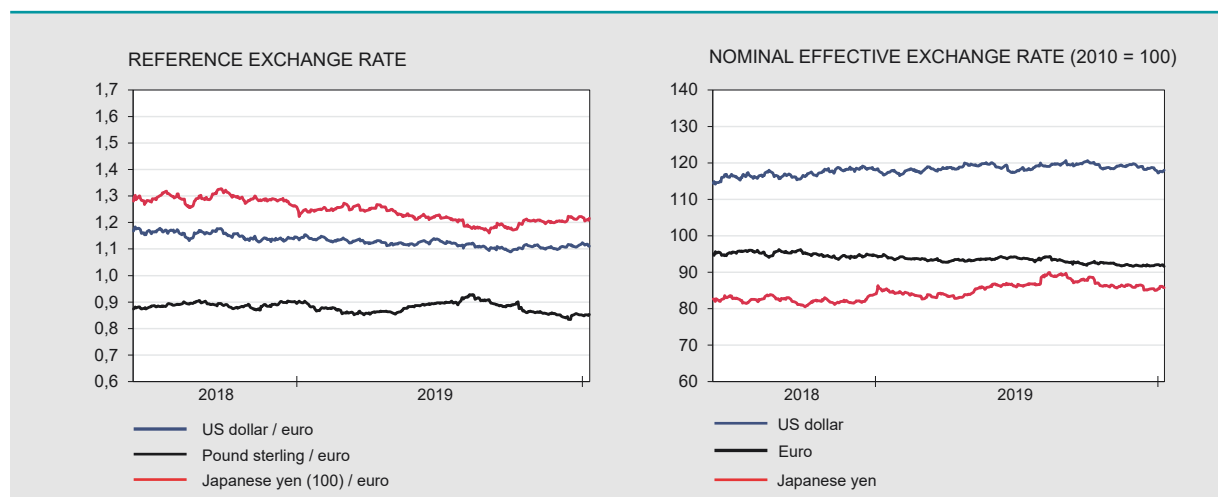

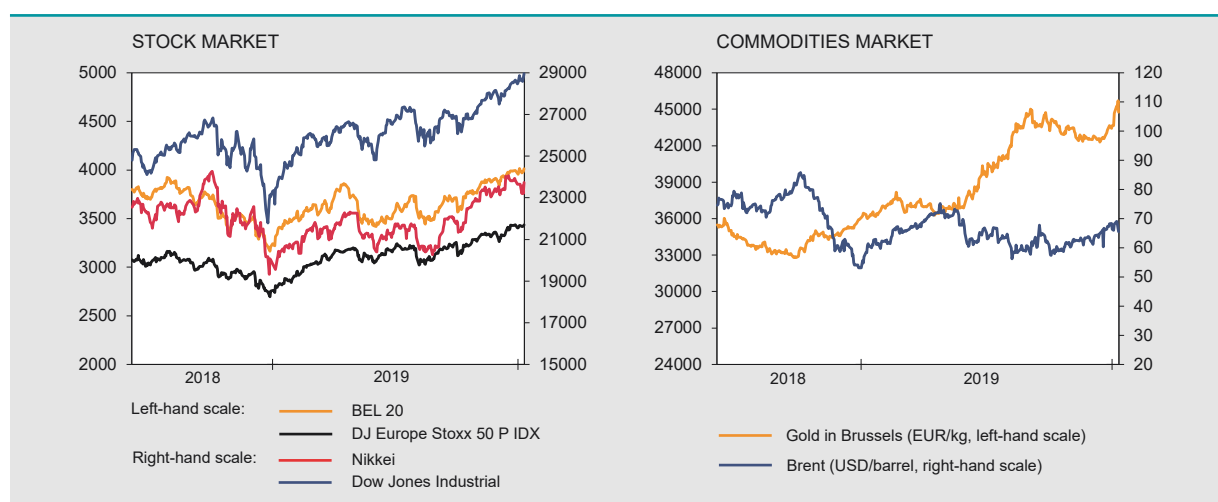
