This role involved various meetings - on a daily basis - with other ERMG members and with public entities (Prime Minister, Ice Prime Ministers &amp; Minister of Finance, representatives of various stakeholders in the Belgian economy (Employers federations, unions, ...). On the 7<sup>th</sup> of April the Governor also became member of the GEES Covid 19 expert group created by the Belgian Government.
